## EAGLECREST VOLUNTEER RULES AND PROJECT INFORMATION

A. Rules for Volunteering to Perform Work on CBJ-Eaglecrest Ski Area Trails or Open Spaces

Safety is a priority while volunteering to work in Juneau's parks, trails, and open spaces. To ensure volunteers enjoy their work and stay out of harm's way the following rules apply and must be reviewed with all volunteers prior to any on-site activities.

- 1. Notify and obtain approval from EAGLECREST Summer Trails Manager of the date, time, location and nature of work to be done.
- 2. Appropriate clothing: CBJ-EAGLECREST will not be responsible for issuing clothing, nor for replacing ruined or dirty clothing. Wear leather gloves, or equivalent, over latex gloves for best hand protection. Wear shoes that cover the toes, have strong soles and are comfortable to stand in for long periods. Be aware of proper protective equipment for hazards that may include sharp objects, loud noises, flying debris, heavy objects, or slippery or difficult terrain.
- 3. Contact EAGLECREST if large items, such as appliances or couches are found and do not try to remove them.
- 4. Recycle any recyclable items (e.g. #1 & #2 plastics, paper products).
- Avoid touching any potentially hazardous items, such as pesticide containers, chemical containers or hypodermic syringes, and notify EAGLECREST if any such items are found.
- 6. Have a first aid kit available at the cleanup site. Having at least one person with a valid first aid card present during cleanup activities is strongly recommended.
- 7. Report any personal injury(ies) to EAGLECREST.
- 8. Provide adult supervision of at least one adult for every eight (8) participants under eighteen (18) years old during activities on site.
- 9. Ensure power tools, including chain saws, are only used by fully trained volunteers 18 years or older. Additional Wavier required for Power Tool use.
- 10. Contact Juneau Police Department at 586-0600 to report any suspicious items or activities.
- 11. Ensure there is at least one person on site during all work activities who can communicate any emergency to the appropriate authority regarding suspicious activities, large or hazardous items, or accidents.

If in the sole judgment of the Eaglecrest Ski Area, it is found that a volunteer or group of volunteers is not following the rules, the Eaglecrest Ski Area may halt volunteer activities immediately.
